Board Chairman, Stanley Storer, called the meeting to order and read the notice of the meeting.

Mark McGuire, with McGuire Brother's Construction, discussed the new housing development at Ruth Street and Slick Road. He asked the board to consider the District pitching in funds to increase the water line to the area to improve the fire flow. Greg Hurst with Legacy Collective LLC discussed the water taps/benefit units. He asked that they be sold to him for the price before the increase in November, 2021 for the Barron's Crossing housing addition. Brent Page with Bronze Oak discussed the Plant Project. Mr. Page said he understands there have been multiple issues and the District is considering filing with his Bond Company. He asked for more time to complete the project. He said he is having staffing issues and after March 23rd, he can be on site at the Plant 3 days a week to monitor his employees more closely. He said he has a sub-contractor, J&A Coating, lined up to take over the painting and tank recoating next week, instead of proceeding with the Bond Company, if that is what the Board decides. Multiple concerns were expressed by Manager Conley, the Board and CEC Employees. Motion - Cornelius, second - Hamlin, the Board give Bronze Oak more time and report back to the next board meeting on April 14th. Motion failed. Voting: Clayton, Holcomb, Hamlin, Morris, Cornelius. All opposed.

Status of the Water District, presented by District Manager Mitch Conley: Updated the board on the Plant Upgrade Project. Got Rate Analysis report back from ORWA. Fixed a few good sized leaks over the freezing days. Hoping that will help our water loss percentage.
