Board Chairman, Stanley Storer, called the meeting to order and read the notice of the meeting.

Attorney Mary Gannaway: The meeting at the Treatment Plant on April 27th went well with Bronze Oak and their attorney. Also present was Bronze Oak's Bond Company (Granite) representative and attorney, and people from District 1, CEC, and Sherwin Williams. Granite brought Superior/Summit representatives from Mustang, OK to inspect the situation and give them estimates/feedback. Bronze Oak asked and was given permission to remove some of their equipment that day, including a welder/generator. In the future, Mary and Bronze Oak's attorney will coordinate a time for them to remove the rest of their equipment and belongings.

Status of the Water District, presented by District Manager Mitch Conley: Had a DEQ Sanitary Inspection at the Treatment Plant. This is a somewhat new inspection that DEQ has started and will be a regular occurrence. Spoke to District 2. They want to meet with us to go over pricing. We need to get current prices to re-do the numbers from ORWA and Engineer, Louis Funk. The numbers used for the current study were from last year, and prices have gone up a great deal. The water loss was up this month. Had several leaks and lines cut - looking for more leaks. Our presentation for the ARPA funding is next Monday, the 16th during the County Commissioners regular meeting. Working to schedule a Board Meeting training class possibly in July.
